► REVIEW OF DIRECTORS' FEES 2020

TRIENNIAL REVIEW OF DIRECTORS' FEES

At the Shipowners' Mutual Protection and Indemnity Association (Luxembourg) Board meeting held on $27^{th}/28^{th}$ November, 2019, in Sydney, the Board considered the triennial review of Directors' fees as presented by the Chairman of the Remuneration Committee.

The fees are assessed every three years and apply to the Board and all sub committees. A benchmarking consultation with Spinnaker Consulting ensured that the fees remain relevant and in accordance with peers. The Directors noted in particular the fees applicable for attendance at meetings outside the cycle of the main Board arrangements. It was proposed that whilst the annual fees be increased the meeting attendance fees are to remain unchanged.

The revised schedule of fees, as shown under Appendix 1, was agreed by the Board to be submitted for approval by the Annual General Meeting.

The meeting is asked to consider the recommendations made by the Board of Directors. If the meeting is of the view that the recommendations are appropriate, it is asked to approve the new level of fees to be implemented from May 2020.
